ADMISSIONS & ELIGIBILITY

Admission Process:

- Visit the official website of Ambedkar Law College.
- Navigate to the 'Admission' section.
- Register by providing necessary details.
- Complete the application form with accurate information.
- Upload required documents, such as educational certificates and photographs.
- Pay the application fee as specified.
- Submit the completed application form.

Eligibility Criteria:

- Undergraduate Programs (e.g., 5-year Integrated BA LLB):
- Candidates should have completed their 10+2 examination with a minimum aggregate of 55% marks.
- For SC/ST candidates, a relaxation of 5% in the aggregate marks is typically allowed.
- Postgraduate Programs (e.g., 3-year LLB):
- Applicants must hold a bachelor's degree with a minimum of 55% marks.
- SC/ST candidates may receive a 5% relaxation in the qualifying marks.

Entrance Examination:

- Admission may be based on the marks obtained in the qualifying examination.
- Some programs might require candidates to appear for an entrance test or counselling process.
- Document Verification and Fee Payment:
- Shortlisted candidates will be notified for document verification.
- Original documents must be presented for verification.
- Candidates will be required to pay the course fees upon confirmation of admission.
- Ensure all documents are in order and fees are paid within the stipulated time frame to secure your seat.

The list of documents required for admission to Ambedkar Law College includes the following:

- **Class 10th Marksheet** – As proof of date of birth and educational qualification.
- **Class 12th Marksheet** – For undergraduate program admissions (e.g., BA LLB).
- **Graduation Marksheet** – For postgraduate programs (e.g., LLB), candidates will need their bachelor's degree mark sheet.

- **Transfer Certificate** – Issued by the last institution attended.
- **Character Certificate** – From the institution last attended or a gazetted officer.
- **Caste Certificate** – For SC/ST/OBC candidates (if applicable), issued by a competent authority.
- **Income Certificate** – If applying for any fee concessions or scholarship.
- **Admit Card and Rank Card of Entrance Exam** (if applicable) – If admission is based on entrance exams.
- **Passport-sized Photographs** – Typically 5-6 recent photographs.
- **Aadhar Card** – For identity verification.
- **Migration Certificate** – If the candidate is from a university other than Bihar (if applicable).
- **Medical Certificate** – In case required by the institution.
